USE RESTRICTIONS: THIS PRODUCT IS NOT FOR USE ON HUMANS

OR ANIMALS: In the home, all food preparation and eating surfaces and utensils should be covered during treatment, or thoroughly washed before use. Exposed food should be covered or removed. Remove pets, birds and cover fish aquariums before spraying. Do not apply as a broadcast surface spray. Not intended for commercial applications.

SHAKE WELL BEFORE EACH USE.

APPLICATION: Use only as a spot treatment or crack & crevice application in residences. Spray in an inconspicuous area to test for the unlikely possibility of staining or discoloration. Evaluate test area after drying. Hold with applicator aimed away from you. Spray surfaces from a distance of 8 to 10 inches until slightly damp. Do not allow children or pets to contact treated areas until surfaces are dry. Allow sprayed articles and surfaces to dry thoroughly before using or replacing bedding.

HOW TO APPLY:

- Turn sprayer nozzle to open.
- Adjust sprayer nozzle as desired.
- Hold 8 to 10 inches from the surface to be sprayed.
- Spray surface until slightly damp.

TO KILL BED BUGS AND BED BUG EGGS: Apply spray as a spot treatment to cracks-and-crevices and/or harborages, where evidence of bed bugs occurs, including bed frames, box springs, inside empty dressers, furniture and clothes closets, carpet edges, high and low wall moldings, behind headboards, pictures, wallpaper edges, and luggage. Spray bed bugs directly when possible. Do not make surface applications to mattresses or bedding. Mattress treatments must be limited to seams, folds, and edges only. Do not treat pillows, bedding, or clothing. Remove linens and wash before reuse. Allow treated mattress to dry thoroughly before remarking bed. Remove all clothes and other articles from dressers or clothes closets before application. Allow all treated areas to dry thoroughly before use.
